Presentation by Giselle Zapata Garcia from the Community Health Access Program **See attached PowerPoint presentation.

CHAP is a King County-focused direct service program assisting families and individuals with access to culturally and linguistically appropriate health care and social services, regardless of their ability to pay.

Presentation was followed by a discussion about opportunities for collaboration. Giselle shared that their staff often get questions regarding environmental health concerns and that they'd like to increase their knowledge about these issues and be able to refer their clients to environmental health agencies/organizations for assistance.

Margo is going to follow up with Giselle about how CHE-WA CEH Working Group can assist. Options include giving training to CHAP staff, providing a directory of environmental health contacts, and/or partnering at the Latina Health Fair or other community health fairs that reach their target audience.

There is an upcoming <u>fair</u> on Saturday, 9/25. Jeanne Johnson will be attending. There is also the big <u>Latina Health Fair</u> in May.

Giselle would love to see more participation from environmental health agencies at these events. She is leaving CHAP, but is hopeful that the new leadership will be supportive of these endeavors as well.

Another opportunity to collaborate is the Ventanilla de Salud (Window on Health). Since 2002, the Washington Health Foundation (WHF) has worked closely with Washington's Latino Community to provide health resources and education. Twice a week, every week, the CHAP helps approximately 100 people connect with health services through the Ventanilla de Salud in Seattle. Additionally, WHF coordinates presentations, advocacy and health education in this community. Medical clinics supporting this program provide free preventive care screenings once a month, services such as cholesterol, diabetes, high blood pleasure, HIV tests and more.

Margo is going to organize a conversation with Lauren Jenks, Julia, and Giselle, about potentially presenting or putting together some informational booths at the Ventanilla de Salud as the Mexican Consulate as well during October to celebrate Children's Health Month, Hispanic Heritage Month, and Lead Poisoning and Prevention Week.
